1. INTRODUCTION

引言

- 1.1. FXTM¹ is running the 2023 October Ger40_m Promotion (the “**Promotion**”) which is applicable to selected clients at FXTM’s discretion, excluding clients assigned under IB & Affiliates. By participating in this Promotion, you agree to be bound by the Terms and Conditions herein (hereinafter referred to as the “**Terms**”) as these are set out below.

本2023年10月德国40指数_迷你优惠活动（以下简称“**活动**”）适用于由FXTM富拓决定的特选客户（代理商及网络联盟商名下的客户不适用）。参加本次活动即表示您同意受以下条款和条件的约束（以下简称“**条款**”）。

- 1.2. This Promotion Period shall run from the MT time 1st October 2023 (00:01) to the 31st October 2023 (23:59) (MT Platform time) inclusive (the “**Promotion Period**”).

活动期由MT平台时间2023年10月1日0点01分开始至10月31日23点59分止（以下简称“**活动期**”）。

- 1.3. A client who participates in this Promotion shall receive the “**e-gift card**” as defined in accordance with clause 4 of this Promotion and subject to the Terms herein.

2. ELIGIBILITY CRITERIA

资格标准

- 2.1. To participate in this Promotion, you must meet the following requirements:

- a) You are an existing client of FXTM with FXTM live trading accounts, or a dormant client of FXTM, eligible to trade in accordance with, and have agreed to, the operative agreements;

您是拥有富拓真实交易账户的富拓现有客户，或是有资格根据有效协议进行交易的FXTM的不活跃客户；

- b) All clients that wish to participate in this Promotion must follow FXTM’s official WeChat service account, bind their MyFXTM account with it before 31st October 2023, and reply

“Ger40” in the WeChat service account before 31st October 2023. If you have been bound to FXTM WeChat service account previously, you only need to reply “Ger40” in the WeChat service account to participate, and not need to re-bind to FXTM WeChat service account.

所有想要参加本次活动的客户必须于2023年10月31日之前关注富拓官方微信服务号（微信名：FXTM微服务），并将您MyFXTM账号和微信绑定，同时于2023年10月31日之前须在富拓官方微信服务号中回复“德指”方可参加活动。现有客户，如此前已绑定，则无需再绑，只需继续关注官方微信并直接在富拓官方微信中回复“德指”即可。

d) Read and accept the Terms of this Promotion;

2.2 The Promotion shall only be available to each client at the discretion of FXTM to offer the **e-gift card** and shall be given to the client after receipt of the client's Acceptance of these Terms.

2.3 Acceptance of these Terms must be express, in writing, and communicated from the client to FXTM via FXTM WeChat Service Account by replying “Ger40_m”. (the “**Acceptance**”).

2.4 TRADING TERMS

交易条款

3.1 The Promotion is applicable to selected account types (Advantage and Advantage Plus).

本活动适用于特选账户类型（超低点差账户及0佣金账户）。

3.2 Irrespective of the number of trading accounts that June be opened by a new and approved client with FXTM, only the Trading Volume (lots) completed under the FXTM trading account with the highest net deposit amount will be considered as eligible Trading Volume (lots) for this Promotion. Therefore, the clients must complete the Trading Requirements in accordance with Clause 4.1 below in the FXTM trading account with the highest net deposit amount.

4 SPECIFIC PROMOTION TERMS

特别活动条款

- 4.1. The amount of the **E-gift card** is based on the eligible trading volume of Ger40_m the client trades in accordance with the table below after the Acceptance of these Terms during Promotion Period.

- 4.1 The above trading requirements stated in clause 4.1. are only applicable to FXTM Ger40_m.

上述条款4.1中规定的交易量（手数）要求只适用于FXTM富拓德国40指数_迷你(Ger40_m)的交易。

- 4.2. To be qualified for this promotion, clients need to meet the minimum trade requirement in accordance with Clause 4.1 above before 31st October 2023. One trade refers to a complete round trip of opening and closing a position. Only positions opened and closed for more than 5 minutes are considered eligible. Long and short position at the same time is not counted as eligible.

为符合享受本次活动的资格，客户需要在2023年10月31日之前满足以上条款4.1所规定的交易量要求。一手合资格交易指开仓、平仓一个来回的完整交易。只有开仓和平仓且开仓时间超过 5 分钟的交易才会被计入交易手数。同时做多做空不会被计入交易手数。

- 4.3. FXTM reserves the right to determine or change the amount and types of the E-gift card and e-gift card to issue to the clients at any point without prior notice.

富拓有权在无需提前通知的情况下在任何时间决定或修改赠予客户的奖金回赠和网上购物礼品卡数额及种类。

- 4.4. FXTM will review eligible clients on 1st November 2023. Regarding the e-gift card, FXTM will deliver the e-gift card to eligible clients via Official Email before 25th November 2023.

富拓将于2023年11月1日对已经合格客户进行审核。所有奖金回赠和网上购物礼品卡将在11月25日前通过官方邮件发放给合格客户。

- 4.5. FXTM shall not be liable for any margin call or losses that the client June suffer, including but not limited to losses due to stop-out level, as a reason of or during this Promotion Period.

根据本条款和条件，FXTM富拓将对客户可能由于本次活动或在本次活动期间所遭受的追加保证金或损失，包括但不限于因强制平仓造成的损失不承担责任。

- 4.6. FXTM has the right to withdraw qualification without prior notice if:

若出现下列情况，FXTM富拓有权撤销获奖资格，无需提前通知：

- a) a breach of these Terms occurs;

- b) FXTM has reasonable grounds to believe a misuse of the Promotion;

- c) The Client acts in bad faith and/or abusively and/or fraudulently and/or in a manner that is not in line with this Promotion and applicable Terms.

- 4.7. During the Promotion Period the client can participate in any other applicable and unexpired promotions announced by FXTM. Please note that if a client participated in more than one promotion, then FXTM will review the client's trading volume (lots) fulfillment in the chronological order of the client's participation order. The same trading volume (lots) can only be counted as eligible trading volume for once. Clients are required to complete the corresponding trading volume requirements for each promotion in the order in which they successfully registered and participated.

5 MISCELLANEOUS

其他事项

- 5.1 FXTM reserves the right, as it in its sole discretion deems fit, to alter, amend, suspend, cancel, or terminate the Promotion. In the event of modifying the Terms, FXTM shall give such notice to the client as June be required by applicable legislation. Under no circumstances shall FXTM be liable for any consequences of any alteration, amendment, suspension, cancelation, or termination of the Promotion.

FXTM富拓保留在自由裁量认为适当的情况下变更、修正、中止、取消或终止本次活动的权利，富拓应根据适用法律的要求向客户发出通知。在任何情况下，富拓不对由于活动的更改、修正、中止、取消或终止造成的任何结果负有责任。

- 5.2 Any indication or suspicion of fraud, manipulation, cash-back or bonus or swap arbitrage, or other forms of deceitful or fraudulent activity in a client's Account or multiple account with FXTM or otherwise related or connected to the e-gift card shall nullify all transactions carried and/or profits or losses garnered therein.

- 5.3 FXTM reserves the right, at its sole discretion, to disqualify any individual that FXTM suspects misuses or attempts to misuse the E-gift card or e-gift card or breaches the present Terms and/or any of FXTM's operative agreements and to cancel all orders and annul all profits of such client. If FXTM, in its sole discretion, suspects any E-gift card or e-gift card arbitrage or any misuse or attempts to misuse the E-gift card or e-gift card, and the client has open positions, FXTM reserves the right to withdraw the E-gift card or e-gift card. In these circumstances, FXTM shall not be liable for any consequences of the E-gift card or e-gift card cancelation.

FXTM富拓保留，在其自由裁量情况下，取消滥用或试图滥用本赠金活动、违反本条款和/或FXTM富拓任何有效协议的客户参加活动的权利，取消此类客户所有定单和所有利润。如果FXTM富拓怀疑客户有任何赠金套利或任何滥用或试图滥用赠金活动的行为且客户已建仓，FXTM富拓保留撤回赠金的权利。在这些情况下，FXTM富拓不负责由于赠金取消造成的任何后果。

- 5.4 Notwithstanding the Chinese language of this document, the English wording shall be the binding version in the event of any discrepancy between the two languages.
